Our school attendance is currently 91.5% - unfortunately we are not reaching our attendance target of 96%+. As you are aware, improving attendance is a key priority for the school. We are a public school and therefore we have to align to government guidelines. I remind you that:

Local Authorities have the power to prosecute parents who:

- Fail to ensure their child's regular attendance at school (section 444, Education Act (EA) 1996)
- Knowingly allow their child to be absent from school without authorisation (section 444(1A), EA 1996)

Please remember that any family holidays planned for the summer term time will not be authorised and could result in fixed penalty notices being served by Cheshire West and Chester LA. All parents **must** complete a **holiday request form** and outline any exceptional circumstances why they need to take their child out of school. As stated above, if you do not inform us of your intention to keep your child off school then the LA has the power to prosecute.

The school has a legal duty to publish its absence figures to parents and to promote excellent attendance. Equally, parents have a duty to make sure that their children attend school.
